Our Commitment

We are dedicated to:

- Ensuring all waste generated from our lawn care and garden maintenance services is disposed of safely and responsibly, in compliance with relevant laws and regulations.
- Minimising waste at the source by adopting sustainable practices and promoting the reuse and recycling of materials wherever possible.
- Reducing our environmental footprint by using eco-friendly products and encouraging biodiversity and soil health.

Waste Disposal Principles

To uphold our commitment, we follow these key principles:

1. Compliance with UK Waste Regulations

We strictly comply with all UK legislation, including the *Environmental Protection Act 1990*, *Waste (England and Wales) Regulations 2011*, and any other applicable local authority regulations. This includes correct handling, transportation, and disposal of both organic and non-organic waste.

- o Reusing materials like garden stakes, pots, or soil where possible in garden projects.
